Open Limited Gun Dog	30 minutes – 8:00 am Friday 5/17/24	\$50
Open Puppy	20 minutes - to follow OLGD	\$40
Open Derby	30 minutes - to follow OP	\$50
Open Gun Dog (Ret)	30 minutes – to follow OD	\$50
Amateur Walking Derby	30 minutes – to follow OGD (Ret)	\$50
Amateur Walking Gun Dog	30 minutes – to follow AWD	\$50

**The Open Gun Dog is a retrieving stake and will have call backs for the retrieve.**

**COURSES AND BIRDS**

All stakes single course. Horseback handling will be allowed in all stakes **except AWD and AWGD**. All Stakes **except Open Puppy** will have Quail released. **Quail will not be released for Open Puppy**. Blank shots will be required in all stakes **except** Open Puppy. No blank shots on the Open Puppy stake.

**NOTE:** Only blank guns with solid filled barrels will be permitted.

No wrangler horses will be provided.

AKC approved tracking collars allowed, but not provided.

**Entries withdrawn after the draw will NOT be refunded unless a bitch is in season, or a dog is injured. An injured dog must have a note from a veterinarian to receive a full refund.**

The Four Lakes GSP Club reserves the right to cancel the Trial due to inclement weather. If the trial is canceled by the Four Lakes GSP Club, full refunds will be given.
